NOTES

1, Not all University of Canberra courses admit international students each year. Those courses marked with an 'No' are not available for that admission period in 2011.

2, The University of Canberra sets its fees according to an annual rate method. The annual rate is the fee that applies to standard full-time enrolment, which is 24 credit points. The final fee charged is based on the proportion of 24 credit points in which a student enrolls. For example, if a student only enrolls in 3 credit points then the student will be charged $3/24 = 0.125 \times$ annual rate. In 2006 the University changed its fee charging method. The annual rate that applies in the year a student commences will apply until the student completes the degree (as long as the student completes in minimum time e.g. completes 24 credit point each year).

3, For the purpose of charging fees, graduate certificates, graduate diplomas and masters courses are considered to be discrete courses, even where they belong to a suite of courses. Accordingly, students who upgrade from a graduate certificate to a graduate diploma to a masters course will be charged at the annual rate applicable for the year in which they commence each course.
