1. Overview

SYNERGY is the Nursing and Midwifery Research Centre based at The Canberra Hospital and is an acknowledgement by the ACT Health Directorate (ACTHD) and the University of Canberra (UC) of the need to support a research culture that encourages engagement and collaboration, achieves regular outputs in key focus areas, enhances collaboration with key stakeholders, establishes international links with other centres, and develops a successful cohort of higher degree research students in nursing and midwifery.

Five areas of research focus have been identified as current strengths based on research outcomes including publications in refereed journals, research income and higher degree student enrolments and capacity:

- Mental Health Nursing and Psychosocial Wellbeing,
- Midwifery/Women Centred Care,
- Cancer and Oncology,
- Health Workforce, Education and Quality Outcomes,
- Gerontological Nursing and Care of the Older Person.

This report showcases the extensive work that SYNERGY undertakes in supporting nurses and midwives to develop, implement, and evaluate innovations that deliver person-centred care and improve outcomes for consumers, carers, and the health system in the ACT and elsewhere. It demonstrates SYNERGY's leadership in exploring, understanding, and reshaping health care services, and in ensuring the next generation of nurses and midwives has the skills and insight to continue to generate and use evidence to enhance health throughout the community.

Mr Anthony Dombkins

ACT Chief Nursing and Midwifery Officer – ACT Health Directorate

Anthony Dombkins is the ACT Chief Nursing and Midwifery Officer, a position he has held since January 2020. Previously the Director of Nursing and Midwifery, Northern Sydney Local Health District, Anthony graduated as a Registered Nurse in 1987 and holds postgraduate clinical certificates in Renal and Transplantation Nursing and Intensive Care Nursing, as well as a Masters, Health Management (UNE). Anthony has held a variety of senior health management positions within the public and private health

sectors across NSW. In June 2014, Anthony was appointed an Adjunct Professor, Nursing with the University of Sydney and the Australian Catholic University. Anthony was also a member of the Clinical Excellence Commission Advisory Board and a Board Director for Stewart House.



Professor Michelle Lincoln

Executive Dean, Faculty of Health – University of Canberra

Professor Michelle Lincoln (B App Sci, PhD, FSPA, PFHEA) is the Executive Dean of the Faculty of Health, University of Canberra. Professor Lincoln was formerly the Deputy Dean, Associate Dean Learning and Teaching and the Head of Discipline of Speech Pathology in the Faculty of Health Sciences, University of Sydney. She was the inaugural chair of the Asia Pacific Education Collaboration in Speech Pathology. Professor Lincoln's research in education is focused on competency-based assessment in clinical settings, clinical education models, ethical development and interprofessional learning. Professor Lincoln writes on and

researches allied health service delivery and workforce, particularly in rural, remote and Indigenous communities. Professor Lincoln's research has been funded by the National Health and Medical Research Council, the Australian Research Council and the NSW Government. She has published more than 130 peer-reviewed journal papers as well as books and book chapters. Professor Lincoln has won university and national teaching awards for her educational expertise in Speech Pathology. She is a Fellow of Speech Pathology Australia and a Principal Fellow of the Higher Education Academy.

Professor Deborah Davis

Clinical Chair and Professor of Midwifery

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Professor Deborah Davis (BN, MNS, PhD) is a midwife with an extensive career in clinical practice (midwifery-led, continuity models of care), midwifery education and research. She is also active in the profession, having served for four years on the Board of Directors for the Australian

College of Midwives, two of which were in the role of Vice President. Professor Davis is committed to improving maternity services for childbearing women, through midwifery education, research, and service development. She supports research students to focus on clinical research that is important to our maternity services in the ACT and has worked with clinicians in the ACT to improve clinical outcomes in areas such as stillbirth prevention and protection of the perineum in childbirth. She has contributed chapters to pre-eminent midwifery textbooks, co-developed the world's first midwifery Massive Open Online Course (MOOC) on evidence-based practice, published extensively in scholarly journals, and plays a leadership role in service development in the ACT. Professor Davis' research interests focus on promoting wellness in childbearing women using salutogenic approaches, particularly in relation to birth environment and weight gain in pregnancy.



Professor Catherine Paterson

Clinical Chair and Professor of Nursing

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Professor Catherine Paterson (PhD, BA, MSc, PGCert. LTA, FHEA) conducts research in all areas of urology and uro-oncology. She has expertise in conducting systematic reviews, ecological momentary assessment methodology, mixed methods, complex interventions, and clinical trials. Professor Paterson has over 17 years' experience working in health services research, has published widely, and

supervises Higher Degree by Research (HDR) students.

Professor Paterson provides senior leadership for the

Prehabilitation | Activity | Cancer | Exercise | Survivorship (PACES) Research Group at the University of Canberra, ACT Health and Canberra Health Services. The PACES clinical academic research group has multidisciplinary healthcare representation from nursing, medicine, and allied health, including consumer representation and Aboriginal and Torres Strait Islander Representation. We will develop clinically meaningful outcomes and what matters most to people living with and beyond cancer, while providing cost-effective solutions to reduce economic burden in primary and secondary care. Our synergistic clinical and academic research partnerships mean we lead and develop research that has translation pathway for impact directly back into practice. Our mission is to improve the lives of the estimated 130,000 Australians diagnosed with cancer each year.



Professor Michael Roche

Clinical Chair and Professor of Mental Health Nursing

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Dr Michael Roche (RN, PhD, FACN) has a wide-ranging research portfolio in mental health and health services using quantitative, multi-, and mixed- methods, including studies that have integrated longitudinal and cross-sectional data to provide new insights. His recent work has focused on professional pathways for mental health nurses, nurse resilience and retention, mental health safety culture,

and workplace violence. He also has wide experience in clinical environments, education, information technology, and management positions in the public mental health system. He has attracted substantial research funding and has many publications, book chapters, conference presentations, and reports. He presently supervises research students exploring aspects of mental health nursing, person-centred care, resilience, workplace violence, and restrictive practices. He emphasises collaboration and engagement in his work and mentors new researchers across clinical and academic settings, for example, leading a team of new researchers across University of Canberra and ACT Health currently engaged in exploring Safewards implementation needs. Michael liaises with mental health and drug and alcohol services and non-government organisations across the ACT. He works closely with the Mental Health Justice Health Alcohol and Drugs Service (MHJHADS) to support nurses in their transition to mental health settings and in developing quality improvement and research activities.



Associate Professor Kasia Bail

Clinical Chair and Associate Professor of Gerontological Nursing

A joint appointment by the ACT Government, ACT Health Directorate and the University of Canberra, Faculty of Health.

Dr Kasia Bail is known for her work examining health services, older people and nursing. Dr Bail's work is positioned at the intersection between 'ageing well' and 'care delivery' by exploring the underlying social causation and impact of clinical prioritisation and decision making experienced by older adults, particularly for people experiencing cognitive impairment. With funding from

industry and government she has examined older person care in relation to digital health systems, nurse sensitive outcomes, health information systems, aged care nurse practitioners, prognosis communication, costs, and dementia care in residential aged care as well as community and hospital settings. Dr Bail maintains casual hospital shifts and enjoys sharing scholarly inquiry with nursing students, industry, and professional groups to address structures and processes that enable quality person-centered care. Dr Bail enjoys co-designing research with the communities that the research serves and works with undergraduate and HDR students and clinicians to identify challenges and opportunities to translate evidence into practice related to person-focussed care for the older person. Key working teams for policy, practice and research impact include the Rehabilitation Aged and Community Services of ACT Health, ACT/SE Regional Team for Service Delivery Division, Ageing and Aged Care Group, Aged Care Workforce Branch, Market and Workforce Division, Australian Government Department of Health and Aged Care, Aged Care Nursing Roundtable, Capital Health Network, Ageing Research Group of University of Canberra, Aged Dementia Health Education and Research (ADHERE) Centre of University of Wollongong, and many individual residential aged care organisations.

2. Research Internship Programme

The Research Internship Programme began in 2021 and aims to provide registered nurses and midwives with an opportunity to develop their knowledge and skills in research.

Supported by the ACT Office of the Chief Nursing and Midwifery Officer, Interns are seconded from their employing division within the ACT Health Directorate on a 0.5FTE basis for a period of 12 months to SYNERGY Nursing and Midwifery Research Centre. During the 12-month placement, Interns complete the Graduate Certificate in Research with the University of Canberra, completing a research project that is relevant to their clinical service area. Interns are provided with mentorship and support from the SYNERGY Clinical Chairs in Midwifery and Nursing.

Previous Interns have emphasised the value of this program both to the organisation and individually. Shalyn Rourke, who completed her project on the unmet needs of people with cancer in 2021, points out:

My service has gained a clinical nurse with research skills that I can take back with me and apply directly to my unit, whether it be with quality improvement projects or the ability to better find up to date evidence to inform practice.

She also noted the impact on her career:

I've gained invaluable experience in nursing research by both the graduate certificate and the completion of a project alongside an academic mentor. I've also had the opportunity to attend a conference and present my research online, representing both my unit and the Canberra hospital. I hope to continue my research endeavours with further studies by undertaking my PhD at the university of Canberra.

Current Interns are undertaking projects that will provide useful information to their service units and to their organisations more broadly, alongside the skills they will bring to their teams.

3. Practice Development Scholarships

Practice Development Scholarships (PDS, renamed SYNERGY Innovation Scholarships [SIS] from 2022) support nurses and midwives to undertake research, practice, or process improvement projects within their work areas with the ongoing support and guidance from their direct supervisor, the Director of Nursing and Midwifery, and an academic mentor.

The aims of the PDS are to increase the evidence base of nursing and midwifery practice, support practice or process improvements in the clinical area and improve outcomes for health service users.

PDS recipients present their findings to the 'SYNERGY Nursing and Midwifery Grand Rounds' with Canberra Health Services nursing leaders and as such contribute to service-level evaluation and development related to their topics.

These projects have significant local impact, for example, the project undertaken by Delilah Shelley to address reports of delayed antibiotic administration in Febrile Neutropenia. Her project evaluated the use of a Medication Standing Order (MSO) for the antibiotic Piperacillin Tazobactam in inpatient haematology. Under the mentorship of Professor Karen Strickland, and in collaboration with key stakeholders, including Dr Nalini Pati (Haematologist), Dr Nicholas Coatsworth (Infectious Disease Specialist), Edwina Smyth (Antimicrobial Stewardship [AMS]), Katherine Wakefield (Director of Nursing in Quality Health and Safety), Melissa O'Brien (Director or Nursing Cancer and Ambulatory) and a Quality Improvement Officer, Delilah examined existing retrospective study data, developed an application for the MSO's approval by the Drugs Therapeutic Committee, and created wardspecific care pathways for Febrile Neutropenia to guide assessment, administration, monitoring and management. The care pathway was endorsed early 2022 and will be formally evaluated by the infection control team led by Dr Kathryn Daveson in collaboration with Delilah. The program assisted in raising awareness of Febrile Neutropenia and MSOs through education sessions on the ward, other areas within the division, and to the relief/casual pool nursing to ensure compliance and safe practice.

Delilah also reports that her project had a major influence on her professional growth:

I developed research skills, learnt new research terminologies, learnt to create new relationships at an academic level, connected with key health professionals within the hospital

and contributed to practice change within my areas. I learnt the style of academic writing, accessing and using research literature, skills in reviewing policy documents, making effective contributions in meetings, and developing and presenting findings. The key highlights from my PDS journey were my contribution to practice change, changing how I care for patients suffering from a lifethreatening condition, and how I teach colleagues. Knowing that my work has and will continue to impact care and safe practice is very rewarding. I am now a PhD student at the University of Canberra.

4. Honours Scholarships

The Bachelor of Midwifery (Hons) and Bachelor of Nursing (Hons) programs are offered to high performing graduates of the Bachelor of Midwifery or Bachelor of Nursing degree. The program involves a supervised research thesis which is undertaken over one-year full time or two-years part time. Most students undertake the program on a part time basis alongside employment in their graduate year or beyond.

The ACT Health Directorate, through the Office of the Chief Nursing and Midwifery Officer, began offering scholarships to graduate midwives in 2013 and nurses in 2015. Midwives and nurses are provided one day per week (funded by the ACT Office of the Chief Nursing and Midwifery Officer) to undertake the Honours program over two years, alongside their employment. Their research project is negotiated with senior health service staff members to ensure it is relevant and useful to the service whilst also within the scope of the Honours program.

This program attracts high performing graduates to ACT Health, beginning with the Centenary Hospital for Women and Children, Canberra Health Services and the Calvary Public Hospital Bruce. Graduates completing the program have high level skills and knowledge in project management, evidence-based practice, research methods and communicating research findings. Graduates from the Honours program are well equipped not only to undertake further research, but to lead quality improvement and other projects, critically appraise evidence for practice, and develop clinical policies.

5. Nursing and Midwifery Grand Rounds: Research and Practice Development Forums

The Nursing and Midwifery Grand Rounds are held monthly in the SYNERGY office at The Canberra Hospital in the Clinical School. Each Forum has 2 presenters who showcase their research on a wide variety of topics relevant to nurses and midwives. The Forums also provide a fantastic networking platform with attendees from various departments across hospitals and academics from universities.

The Forums were postponed in July 2021 in response to the COVID-19 pandemic and recommenced in May 2022 in a hybrid format (virtual and face-to-face), ensuring flexibility in attendance for all nurses and midwives across the ACT. Participation has been strong with up to 9 attendees per Forum and 46 in total. All sessions are recorded and are available on the SYNERGY website: https://www.health.act.gov.au/health-professionals/nursing-and-midwifery-office/webinars.

6. Research Development Series

The Research Development Series features a range of virtual Forums for all levels of healthcare practitioners to explore innovation in practice, and to champion and lead service design. Forums are held online monthly to support healthcare practitioners to develop skills, knowledge and research skills and capability. Each Forum includes a presentation to cultivate critical thinking to lead cutting edge research in healthcare.

Since re-commencement in June 2022, the series has attracted 169 participants in total, with a high of 33 in the September 2021 session and an average of 23 overall. 7. SYNERGY Impact

One of SYNERGY's main roles is to facilitate the translation of evidence into practice, to positively impact patient, nurse, and health system outcomes. A key component of this work is the engagement and support of clinical nurses and midwives, and junior academic researchers. Developing, undertaking, and disseminating research with clinicians develops an understanding of rigor with impact on quality initiatives and translation of research into clinical practice. Over time this develops a community of clinicians with the capacity to access, translate, and apply research to their work. This leads to both immediate and clear policy or practice change (for example, see internship and scholarship vignettes above), and translation that develops over a longer period. The latter is particularly true when practice change is significant, for example, the lengthy change of mental health services to a personal recovery focus. Engagement and interactions raise consciousness and are a key component of the theory to practice translation work. Nonetheless, SYNERGY's work has had considerable immediate impact on the Canberra health community and more broadly. The following examples highlight this impact:

Paterson, C. Featured Article (2021). These projects aim to improve the lives of Canberra residents living with serious illnesses, with
more than 160 participants and their family members set to benefit. The team of researchers and

youth mental health conditions. These programs will break new ground in rehabilitation and
treatment and enhance people's quality-of-life.

ACT Health Directorate funded project investigating comprehensive care documentation:

- Directly created the assessment and screening instrument that was implemented following the research, and then directly informed the creation of the Digital Health Record (DHR) translation via EPIC. Of note was an increased focus of 'what are the patient goals of care today' in activating the patient voice in hospital systems.
- This project has also two drafted publications, not yet accepted, for the 2021 Honours
 Scholarship student Gabriella Michl, associated with the project. These draft publications are
 currently informing the interRAI assessment suite internationally via the interRAI meeting in
 Quebec City, Canada.

The system was found to be acceptable to staff and residents, and to enhance efficiency. The quality of resident care was enhanced with staff able to spend more time with residents and to respond to their needs more effectively. The system had multiple media reports, is recommended by Council of The Aged (COTA), and has been taken up in other sites across the country,

• How do you know if the care you are providing as a midwife, is woman centred? What factors (education, model of care, for example) enhance midwives' ability to provide woman centred care? Led by Professor Deborah Davis, a team of researchers from Australia and New Zealand developed the Woman Centred Care Scale (Davis et al., 2021) to enable questions like these to be answered. The team have received numerous requests to validate the instrument in different countries. Currently, Queensland Health is using the instrument to measure the impact of the introduction of midwife ratios in some maternity services in Queensland.

Establishment of GENA: Gerontological Alliance of Nurses Australia; co-founded by Associate Professor Kasia Bail and Professor Victoria Traynor at the University of Wollongong. This project has been rolled out in association with the Transition to Practice Program for
Residential Aged Care funded by the Australian Commonwealth Government. Associated practice
impacts include 117 new graduate nurses commencing program in aged care; new clinical
placements with gerontological nurses within Canberra Health Services (RADAR and GRACE
teams). It will also impact policy by enhancing eligibility criteria for transition to practice
applicants.
