## **Advertising positions on University of Canberra CareerHub**

CareerHub is an online jobs and events portal that allows individuals, businesses, government and not-for-profit organisations to advertise job vacancies, voluntary positions, internships, and other opportunities to University of Canberra (UC) students and recent graduates.

CareerHub at UC is managed by Careers UC.

A person/organisation wishing to list an available opportunity may add an advertisement subject to the following terms and conditions. The use of 'we' and 'our' throughout this document refer to the University of Canberra.

#### **Terms and Conditions**

- Opportunities advertised on CareerHub will be displayed free of charge for employers and community-based organisations. Third Party Recruiters and recruitment agencies may incur a fee for service. Any charges made by the University of Canberra will be at the discretion of the Manager, Careers UC.
- All opportunities placed on CareerHub must comply with The Fair Work Act (2009) and any other relevant legislation.
- The Advertiser/Employer/Organisation indemnifies University of Canberra against all claims, actions, suits, liabilities, costs and expenses incurred on any account by CareerHub as a result of listing or intended listing of any advertisement by that advertiser/Employer/Organisation on any related site.
- Careers UC makes every effort to avoid errors in advertisements on CareerHub. However, we accept no responsibility or liability for any errors and require that advertisers check their advertisements for facts as soon as they are placed on the site(s). Any necessary amendments can be requested immediately.
- Careers UC reserves the right to either reject or remove any advertisements from its site for any reason whatsoever.
- Careers UC makes every effort to publish advertisements in the shortest possible time over normal business hours.

#### Requirements for advertisers

To be eligible for registration on CareerHub, advertisers must provide:

- Trading and/or business name
- ABN registration number
- Country of business
- Physical address of the business
- Website address
- Email address and phone number
- Number of Employees
- Scope of Operations
- The industry of the business

#### For recruitment agencies/third party recruiters

- Recruitment agencies may be charged a fee for placing advertisements on CareerHub. Please contact Careers UC for the exact cost via <a href="mailto:careers@canberra.edu.au">careers@canberra.edu.au</a>
- Recruitment agencies must disclose to Careers UC the organisation they are recruiting for.
- All vacancies will be accepted at the discretion of the Careers UC staff
- Only genuine job vacancies will be considered for approval
- Advertisements designed specifically for the purpose of collecting student data for prospective positions, will not be accepted
- All roles advertised, which are based in Australia, must comply with relevant Australian laws, including Fair Work legislation, relevant awards or workplace agreements and Anti-Discrimination legislation.

### The following advertisements will not be accepted

- · Any position which does not meet Australian workplace law for minimum wage or national employment standards
- Commission only positions
- Work without pay, unless listed by a registered charity or not for profit organisation, or where the position meets the requirements of a for-credit UC work integrated learning unit
- Jobs where a wage is not guaranteed and is relied on a success of a product, service, or business concept
- Roles which require students to register as an independent contractor
- Illegal activity or roles that pose serious threat or harm to its employees
- Opportunities which require students to pay an application or registration fee, or enter a competition
- Opportunities to participate in an unapproved or unethical research study
- International opportunities will be considered on an individual basis. Paid roles will only be approved where the exact job details are clear and local pay rates are advised to Careers UC.
- Any position that relates to work with or connected to companies that sell tobacco or where such employment would not be consistent with the principles of University of Canberra's Tobacco-Free University Policy. Whether a position is or is not consistent with this policy will be decided by the University of Canberra in its absolute discretion.

<sup>\*</sup> As a general rule, roles listed by individuals for gardening, cleaning, babysitting, tutoring etc will not be approved. However, home based positions, where an individual is registered under the NDIS, and has formalised a business structure for the NDIS i.e., a government program, meeting relevant legislation, may be considered for approval.
