The meeting was held *in camera* for the discussion of Items 1.1 to 1.4 and Item 7. The ACT Chief Minister, Mr Jon Stanhope, attended the meeting at 3.30 pm at which time the meeting was suspended and opened to the public. The meeting recommenced at 5.00 pm.

Opening and Apologies

The apology noted above was received.

Professor Moses welcomed the following new and returning members to Council: Mr Daniel Hughes; Mr Hussain Faiz; Mr Dale Kleeman and Mr Lyndon Mayfield.

Confirmation of the Agenda

The order of the agenda was confirmed with Council requesting that Item 7, Budget 2007, be discussed as a confidential item.

Disclosure of Conflicts of Interest

No disclosures were made.

The following items are recorded in the confidential minutes.

1.1 Election of Council Members

Resolution C108/1

Council:

- 1. received and noted the results of the elections;
- 2. agreed, in this instance, to allow an elected staff member, Mr Hanratty, to serve on Council beyond the permitted statutory maximum of twelve years but only until the current membership of Council was dissolved to give effect to the new membership structure; and
- 3. agreed that in future no member should be permitted to serve on Council beyond the statutory maximum.

1.2 Vice-Chancellor Selection Panel Progress Report

Resolution C108/2

Council:

- 1. noted the Chancellor's report; and
- delegated to the Chancellor the authority to negotiate with the candidate recommended
 for appointment to the position of Vice-Chancellor a salary package comparable in value
 to the current Vice-Chancellor's package comprising: salary; 17% superannuation;
 residence; motor vehicle and entertainment allowance; a performance bonus based on the
 University's performance in accordance with key performance indicators determined by
 Council.

1.3 Appointment of Emeritus Professors

Resolution C108/3

Council agreed to amend Clause 3 of the *Guidelines for the Appointment of Emeritus Professors in the University of Canberra* to read: "The title may be conferred on a person who has held the rank of professor at the University of Canberra for less than five years if they have also held that rank at another recognised university and the total period of service as a professor is at least five years;"

Mr Urban requested that his dissent from this decision be recorded as a member of Council would benefit from it.

Resolution C108/4

Council agreed to appoint Brian Roberts as Emeritus Professor of the University of Canberra to take effect on the date his contract as the Director of the Centre for Developing Cities and as an employee of the University ends.

Resolution C108/5

Council agreed to appoint Ingrid Moses as Emeritus Professor of the University of Canberra with immediate effect.*

*Note: Professor Moses was not present for the discussion of this item. The Deputy Chancellor took the Chair.

1.4 Council Membership

Resolution C108/6

Council agreed to delegate to the Chancellor and the Vice-Chancellor the responsibility to recommend to the Chief Minister, for appointment to the re-structured Council, the names of those members they considered to have the most appropriate skills, as determined in the recent skills audit, and taking into consideration the candidate recommended for appointment at Council's meeting No. 103 of 7 December 2005.

Mr Urban requested that his dissent from this decision be recorded.

Item 2: Chancellor's Opening Comments

The Chancellor reported on the following matters.

- The Bologna Process. Professor Moses had given a keynote address at the Annual Conference of the Australian Tertiary Education Managers on the Bologna Process and had been invited by the Federal Department of Education, Training and Science (DEST) to be a panellist on the Bologna Process National Seminar held on 7 September 2006. It was still unclear if the Process would have an impact on the structure of Australian degrees which were in some ways similar to that being proposed in Europe.
- <u>Diploma Supplement</u>. Australia was obligated under the Lisbon Recognition Convention to promote the use of the Diploma Supplement. The Supplement would make an Australian qualification more understandable internationally and would facilitate study and employment opportunities for graduates. Professor Moses had been invited by Mr Colin Walters to address the Higher Education Group, DEST, on their strategic planning day and had indicated that if DEST was to introduce the Supplement institutions needed to have time and funds if systems changes were required.
- ACT Government Matters. Professor Moses had met with the Chief of Staff for the ACT Chief Minister to discuss the planned review of collaboration between the University and the Canberra Institute of Technology (CIT). While the review was still on the agenda, the urgency seemed to have gone. The Chancellor had met with Ms Martha Kinsman, former Deputy Director, CIT, and Chief Executive Officer of the Gordon Institute of Technology and Further Education, to discuss an options paper she was preparing for CIT relating to the review.
 - The revision of the enabling legislation was also discussed. It was expected that the amended *University of Canberra Act 1989* would be introduced into the Legislative Assembly in November 2006. The revised membership structure of Council should come into effect on 1 January 2007.
- <u>Focus on Business Conference</u>. The Chancellor had participated in the Focus on Business 2006 Conference held on 13-15 September 2006.
- Chancellors' Conference. The Chancellor would be attending the next meeting of Australian University Chancellors on 10 October 2006. The review of the Australian Vice-Chancellors Committee had suggested that the Chancellor's Conference might be serviced by the AVCC when reconstituted as Universities Australia, and that it have an enhanced role as a unified advocate for Australian universities.

Item 3: Confirmation of Minutes of the Previous Meeting

Resolution C108/7

Council accepted the minutes of Meeting No. 107 as an accurate record of proceedings with the following amendments.



Council suggested that the key performance indicators (as outlined above) were very broad and would be difficult to measure. They needed to be improved by being made more specific.

Council also suggested that consultancies could also be a measure of successful community engagement, and that University should fully explore the opportunities for increasing contact with alumni and the community afforded by the fortieth birthday celebrations planned for 2008.

Item 6: Vice-Chancellor's Report

The Vice-Chancellor reported on the following matters.

6.1 Information Updates

- Professor Carole Kayrooz had accepted appointment as the new Pro Vice-Chancellor Communication and Education.
- Professor Andrew Cheetham would leave the University in early 2007 to take up an
 appointment as Pro Vice-Chancellor (Research) with the University of Western Sydney.
 A review of the research and information management portfolio would be conducted
 before commencing the recruitment process.
- The Vice-Chancellor would continue to discuss the development of a Belconnen Arts Centre with the Chief Minister's office staff.

6.2 Enrolments

Council noted the 2006 enrolment outcomes and an overview of the commencing enrolment loads for 2004-2006 for Commonwealth supported, onshore and offshore international students which showed a decline in enrolments. It was also noted that the number of Commonwealth supported places had increased in terms of total numbers, but the ratio between student numbers and EFSTL undertaken had increased, leading the University not meeting its target load.

6.3 DEST Funding Agreement for 2007

The Federal Minister for Science, Education and Training, the Hon. Julie Bishop, was considering a range of options for dealing with the financial consequences of universities failing to achieve enrolment targets. Many universities were in that position, and the Minister had indicated she would meet with vice-chancellors individually to discuss future plans. Universities may be able to retain some of the funding relating to unmet demand.

6.4 National Protocols for Higher Education Approval Processes

The Ministerial Council on Education, Employment, Training and Youth Affairs had approved revised *National Protocols for Higher Education Approval Processes*. The Protocols regulate the recognition of new universities, the operation of overseas institutions in Australia and the accreditation of courses. Several new provisions in the Protocols were expected to permit more diverse types of higher education institutions to develop in Australia.

6.5 Research Quality Framework

The Research Quality Framework Development Advisory Group, chaired by the Australian Chief Scientist, had been established to advise the Federal Government on the next phase of the development of the Framework.

6.6 Australian Vice-Chancellor's Committee

The Australian Vice-Chancellor's Committee would be restructured as *Universities Australia* and would focus more on advocacy and mirror the activities of other major peak industry bodies in representing the interests of Australian universities.

The New Generation Universities had developed a charter and would continue to discuss the possibility of being joined by some more non-aligned universities.

6.7 University of Canberra Workplace Agreement

The University of Canberra Academic, General and UCELI Staff Workplace Agreement 2006-2008 was formally approved by staff on 30 August 2006. The agreement had been lodged with the Office of the Employment Advocate. The Senior Staff agreement had also been approved and lodged.

6.8 University of Canberra Clubs and Societies

The University of Canberra Students' Association and the University of Canberra Union Ltd had responded to an invitation to tender for the provision of support for student clubs and societies on campus. The responses were being evaluated.

6.9 Strategic Plan

Council received a tabled paper providing a revised draft of the Strategic Plan 2007-2010 dated 10 October 2006.

Council noted that a number of changes had been made to the draft plan in light of the discussions held with the staff of the University and advice from Council members.

Council also noted that all of the candidates for the position of Vice-Chancellor had expressed an interest in having input into the strategic plan. In addition, as it was anticipated that the membership of Council would be restructured from 1 January 2007, Council agreed to delay consideration of the strategic plan until early in 2007 by which time the new Vice-Chancellor would have been appointed, as well as the members of the new Council. The Vice-Chancellor confirmed that the delay need not impede the activities of the University.

Item 7: Budget 2007
