Council, on the recommendation of the Finance Committee and Campus Development Board:

- 1. authorised the Vice-Chancellor to negotiate the purchase of Wing 4 of the Cameron Building for the purpose of conversion to student accommodation;
- 2. approved the redevelopment of Wing 4 of the Cameron Building to student accommodation subject to the Vice-Chancellor being satisfied with the funding agreement negotiated with the ACT Government, the construction contract negotiated with the preferred supplier and the final business case for the project; and
- noted that the Vice-Chancellor, in reaching a decision on whether to proceed with the redevelopment of the Cameron Building, will consult with Chair of the Finance Committee.

Item 8: Chancellor's Opening Comments

Mr Mackay complimented the University for the progress it had made over the past few years resulting in positive media coverage and much improved community relationships.

Item 11: Vice-Chancellor's Report

Professor Parker reported that it was 44 years to the day since Prime Minister John Gorton had formally opened the University.

Professor Parker reported on the following matters.

- <u>Guest Speakers</u>: The public lecture series was attracting prominent speakers to the University but attendance at the lectures was not always as strong as desired.
- <u>Strategic Plan 2013-17</u>: A draft Strategic Plan had been drafted in consultation with the University's stakeholders.
- <u>Enrolments</u>: Enrolment patterns for 2013 were variable with some indicators showing improvement and others not. The trends were consistent with enrolments having peaked.
- <u>Graduations</u>: The Graduation ceremonies held in September had been successful and had provided a good showcase for the University.
- <u>Honorary Doctorates and Emeritus Professors Dinner</u>: A very successful dinner had been held for the University's Emeritus Professors and recipients of Honorary Doctorates.

The following points were noted in discussion.

- There were examples of secondary schools forming networks to provide students with a greater range of subject choices than would be available at any one school. This model of education could be promoted within the ACT school system.
- Approaches were being made to possible partners for the Civil Engineering degree.
- The ACT Government had pledged for \$5m for the creation of the Sports Hub during the
 election. Some sporting bodies in the ACT were being approached to establish if they
 would like to collaborate in the formation of the Sport Hub as pooled funding would
 allow for larger and higher quality facilities to be built and accessed.

• The arrangements with the Brumbies were still to be finalised but would need to include matters such as access to the oval being constructed for their use.

Resolution C153/9

Council received and noted the report from the Vice-Chancellor.

Item 12: Strategic Review – Faculty of Arts and Design (Presentation by Dean - Professor Lyndon Anderson

Council received a presentation from Professor Lyndon Anderson, Dean of the Faculty of Arts and Design. The main points of the presentation were as follows.

- The Ernst & Young report *University of the Future* had identified the major challenges to be faced by Australian universities over the coming years and the drivers of that change.
- Creative industries in China and India which drew on the disciplines supported by the
 Faculty of Arts and Design were experiencing high levels levels of economic growth and
 provided significant development opportunities for the University.
- There were, however, significant threats as well coming from emerging technologies, developments such as the introduction of massive online open courses and the high level of competition in the market for students.
- The Faculty of Arts and Design would need to move more of its content online, refine that content and ensure that it maintained pace with current developments.

The following points were noted in discussion.

- Accreditation processes needed to keep pace with technological change so that the faculty was able to deliver material that was up to date and relevant to students.
- A distinction could be drawn between 'information' and 'knowledge' with the latter being a critical function of the educational process whereby students are provided with the skills to develop a deeper understanding and ability to process information.

Resolution C153/10

Item 13: Financial and Budget Matters

Mr Lines reported that the University Group had achieved an overall result to 31 September 2012 that was \$5m favourable to budget. The forecast for Semester 2 was, however, less positive and, combined with expenses known to occur in the latter part of the year, would see the surplus diminished with a forecast result of approximately \$700k better than budget. Mr Lines also reported that expected capital income would be reduced in the second half of the year due to timing reasons, but a break even operating result should be achieved.

Council noted that the receipt of the Structural Adjustment Fund funds would dramatically alter the end of year result.

14.2.1 Establishment and Disestablishment of Faculties - Faculty of Information Sciences and Engineering

Resolution C153/18

Council:

- approved the Faculty of Education, Science, Technology and Mathematics as the name for the new faculty established by Council at its meeting of 31 August 2012 (*Resolution* C152/19); and
- exercised its power under Section 20(c) of the Act and removed the designation of the Faculty of Information Sciences and Engineering as a faculty for the purposes of Academic Board membership, effective from 1 January 2013.

14.2.2 Changes to the Academic Calendar from 2014

Council noted that the changes proposed to the Academic Calendar brought it closer in line with that of other universities and was supported by students. Council also noted that no industrial issues were expected to be raised as a result of the changes but that the National Tertiary Education Union had raised concerns about possible impacts on the quality of courses. In response to this latter concern, Professor Klomp advised that the quality of courses should not be affected by the changes to the Academic Calendar because there is no reduction in the content within the curricula, nor any reduction in the workloads of each unit (approximately 150 hours per unit), and there was an opportunity for our current teaching approaches to be re-considered, including greater use of online content and an expectation that the first and last teaching weeks of each semester would be used more efficiently.

Council also noted that the changes were not expected to have an impact on the accommodation contracts of student housed in student residences.
