# Item 12: Vice-Chancellor's Report

The Vice-Chancellor reported on the following matters.

- <u>Achievements in 2013</u>: Negotiation and approval of the Enterprise Agreement; improved academic performance; completion of the 2014-16 Funding Agreement with the Commonwealth Government and the gaining of Commonwealth Supported Places for the Australian Polytechnic Network.
- Applications for 2014: Total applications for 2014 had increased slightly but were
  markedly different in composition, with more direct applications now being received.
  The Faculty of Health was experiencing strong growth, while two other faculties would
  quarantine part of their budget in case student load projections were not achieved.
- <u>University of the Third Age</u>: Agreement had been reached with the University of the Third Age to allow students to audit classes.

Professor Parker extended his thanks to Professor Skidmore for her contribution to the University and wished her well in her new position at the University of Queensland.

Council noted that a study by Access Economics had shown that the local population of typical university age was not expected to pick up until around 2018 and then only slightly. It was also noted that there was a growing trend for ACT students to move interstate to attend University and that this was not matched by students choosing to study in the ACT.

#### **Resolution C161/13**

#### **Item 13: YTD Financial Performance Report**

Mr Lines reported a positive variance of \$3.9m at the end of October 2013 and that an operating surplus of \$4.0m (\$0.4m behind budget) was expected for 2013.

Council noted that revenue was the main risk to the budget and that expenditure was being decreased to achieve the forecast surplus. It was also noted that the University was required to account for the Structural Adjustment Fund in 2013 to comply with Australian Accounting Standards.

### Item 15: Approval of 2014 Budget

Mr Lines commented that 2012 was the first year the University had achieved an operating surplus for many years thanks to the efforts of the Vice-Chancellor in improving the financial management of the University. Mr Lines noted that the improved financial performance opened up new opportunities for the University and advised that the reportable deficit expected in 2014 was result of the timing of revenue and expense recognition associated with the Structural Adjustment Fund and the manner in which the University was required to account for this grant.

Mr Lines advised that the Finance Committee had approved the 2014 Budget.

Ms Williams provided the following comments on the budget:

- earnings, before interest, taxes, depreciation and amortisation (EBITDA) showed an increase of \$31.8m over the forecast 2013 result and demonstrated the financial health of the University and its increasing capacity to achieve its strategic objectives; and
- the debt profile of the University would peak in 2014 at \$135m. While this would impact on financial ratios, it was expected and flagged the issues the University would need to address over coming years.

Council noted that there were contingencies available to the University in the event that the budget proved unworkable and requested that the Finance Committee immediately inform it of any significant budget variations.

Council noted that the format of financial reports made them difficult to read and requested that efforts be made to improve them or make hard copies available to members at meetings.
