## 4.4 OTHER MATTERS FOR DISCUSSION AND/OR DECISION

## 4.4.1 COVID-19 Planning and Response

The Vice-Chancellor and members of the Executive Team provided an update on the University's management of the likely impact of the COVID-19 pandemic on University operations. Some of the key matters raised were the following.

### a) MANAGEMENT

- An ACT Health Emergency was declared by the ACT Government at 1.00pm today, 16 March 2020.
- The University is following all government advice in relation to its response to COVID-
- On-campus health related services such as the ICON cancer centre, medical and counselling clinic and the health hub are remaining open.
- A revised University Pandemic Plan will be finalised in the next few days.
- Ms. Vicki Williams, the Vice-President Finance and Infrastructure (VPFI) has been appointed to lead the University's COVID-19 response for a three-month period with Mr. David Formica assuming the role of Acting VPFI during that time.
- The University's Critical Incident Team has been meeting twice weekly and the Executive Team are meeting every weekday morning to discuss and implement the University's response the COVID-19 pandemic.
- Social distancing and meeting protocols have been implemented across the University.
  There will be a continued focus on educating staff and students on cleaning and hand
  washing with cleaners paying particular attention to hard surfaces such as handrails
  and counter tops.
- Communications Plans and FAQs are currently being prepared.
- The Council Planning Day scheduled for 30 April will be rescheduled to a future date.
- Professor Paddy Nixon arrives on Friday 20 March and will be in isolation at Bimbimbie for 14 days.

# b) STAFFING

 At this stage there is no government directive to work from home. The approach being taken is "business as usual". • Staff may work from home by agreement with their manager taking into account their individual circumstances. Issues of WHS and insurance will need to be considered before any work from home directive is issued.

# c) GRADUATION CEREMONIES

- Graduations have been cancelled with all graduands to be admitted to their awards in absentia.
- All graduates will be offered the opportunity to attend a ceremony at a later date. The Chancellor will record a video link to be attached to an email advising graduands of the cancellation.
- A Graduation Handbook will still be produced.

# d) STUDENTS

- There are currently 264 University students offshore of which one will arrive on 17
   March. 121 students have requested a deferral of Semester 1 and 143 students have not advised of their intentions regarding their 2020 studies.
- Approximately two thirds of these 264 students are continuing and one third are commencing.

## e) LEARNING AND TEACHING

- All face to face classes are currently proceeding as normal although planning is underway for alternative modes of delivery.
- Most enrolled students will be able to continue studies online but some rescheduling may be required eg for work placements.
- Deferred and online course assessment options are being considered.
- Changes to delivery mode and course structure may need to be referred to the Academic Board.

## f) RESEARCH

- Any proposed remote working or teaching obligations could impact contractual obligations and milestones under grants.
- International HDR student may encounter issues with their visas and scholarships which may need to be extended.

# g) CAMPUS

- The University is working with Unilodge to look at the possible impact on student accommodation.
- The University will need to have a clear understanding of what is meant by "closing the campus".
