

UNDER 18 STUDY OPTIONS

INTERNATIONAL STUDENT INFORMATION

Australian Government regulations require that the University of Canberra ensure that international students who have yet to turn 18 at the time they commence their studies, have appropriate accommodation, support and general welfare arrangements in place. The University offers three different options for students.

Option 1 – Be accompanied by a parent or guardian

Students can be accompanied to Australia by a parent or legal guardian until they turn 18 years of age.

Students must submit:

- *A Welfare Arrangement Form for Under 18 Students*

Option 2 – Nominate a relative

Students can nominate an appropriate relative in Australia who will act as their guardian until they turn 18 years of age.

The Department of Home Affairs (DHA) must be satisfied that appropriate welfare arrangements are in place for under 18 students before a visa is granted.

DHA considers that following relatives as appropriate to be nominated as responsible for the welfare of under age students:

- A grandparent or step-grandparent
- A brother or step-brother
- A sister or step-sister
- An aunt or step-aunt
- An uncle or step-uncle
- A niece or step-niece
- A nephew or step-nephew

A suitable relative needs to be:

- Nominated by a parent or legal guardian of the applicant
- At least 21 years of age, and
- Of a good character

Students must submit:

- *A Welfare Arrangement Form for Under 18 Students*

Option 3 – Nominate the University of Canberra to be responsible for accommodation, support and general welfare

Where the University is nominated to take on responsibility the student will be required to register with *ISA Guardian and Welfare Service* and with the *Australian Homestay Network (AHN)*.

These organisations are the *only* providers which satisfy the University of Canberra's requirements for under 18 students. Further information on these services can be found at www.studentguardians.com and www.homestaynetwork.org.

NOTE: The University recommends that you do not engage in a contract with either ISA or AHN until you have been directed to do so by the UC Admissions Office.

On direction from the Admissions Office, students should submit:

- *A Welfare Arrangement Form for Under 18 Students*
- Evidence of your contract with ISA Guardian and Welfare Services
- Evidence of your agreement and homestay placement with AHN

CoE's and CAAW's will only be issued once all required information has been received by the Admissions Office.

Welfare Arrangements for Under 18 International Students Policy

1. PURPOSE: The purpose of this policy is to ensure that under Commonwealth Migration Regulations an international student under the age of 18 will be granted a student visa if he or she demonstrates that they will live in Australia:

- with a parent or legal guardian;
- with a relative over 21 years of age who is nominated by a parent or legal guardian; or
- under a welfare arrangement that has been approved by an Australian education provider.

The University of Canberra is subject to the National Code of Practice for Providers of Education and Training to Overseas Students 2018 (National Code 2018). Standard 5 of The National Code 2018 specifies the safeguards a registered provider must have in place if it is to take on responsibility for approving the accommodation, support and general welfare arrangements for an international student who has not turned 18.

This policy sets out the University of Canberra provisions relating to that responsibility.

2.SCOPE: The policy applies to all international students enrolled in courses provided by the University of Canberra and the University of Canberra College (UCC).

3. PRINCIPLE: 3.1. The University of Canberra requires prospective international students under the age of 18 to demonstrate that:

- they will live in Australia with a parent or legal guardian; or
- they will live in Australia with a relative over 21 years of age who has been nominated by a parent or legal guardian; or
- they will live in Australia under welfare arrangements approved by the University with a minimum age for accepting international students under those arrangements set at 17 years of age; until such time as they turn 18 years of age.

3.2. The University of Canberra will undertake appropriate selection, screening and monitoring processes of any third parties engaged to organise and assess welfare and accommodation arrangements

3.3. Implement processes to manage and/or report cases where:

The University is unable to continue to approve the welfare or accommodation arrangements for a student;

- The student is uncontactable or there are concerns for the student's welfare;
- The student is transferring from another provider or where a student of whom the University of Canberra is approving accommodation and welfare is transferring to another provider.
