

## **Communique University Council Meeting C259, 6 November 2025**

The University of Canberra Council met for its sixth ordinary meeting of 2025 on Thursday, 6 November.

The Vice-Chancellor's Report included strategic updates aligned with *Reconnected* regarding: an additional 300 international student places have been awarded to the University; an international education strategy will be developed to scaffold and prioritise work across international student recruitment, transnational education and global learning. A range of high value partnership arrangements are in progress that will lead to increased enrolment for the University. Seven CIT diplomas now enable students to gain 1-year credit toward their UC degree. UC's successful partnership with Keypath is being expanded with additional co-designed online courses. The new *VC's Centre for Public Ideas* to be launched on 7 November will build UC's profile as a hub for Government and Policy. Promising campus development matters were also advised.

**Strategy and Performance:** Council noted the Corporate Performance update for September and accepted the Interim 2025 report on University Performance. A comparison paper was discussed showing UC's performance in comparison with 31 universities shown in the Korda Mentha Higher Education Annual Report.

The **2024/25 Organisational Restructure Evaluation** paper, requested by Council, was considered noting the 2024 Q4 / 2025 Q1 Restructure had resulted in resourcing now being aligned to revenue, with staffing reduced by 13.7%, removal of additional management layers, reduction in operational costs of 17%, and a positive recovery in staff sentiment shown in the Biennial Staff Survey. Council recognise staff wellbeing remains a priority.

**Finance: The 2026 UC Group Budget** was approved by Council on the recommendation of the Finance Committee. The Budget provides the financial plan to deliver *Reconnected*, plans a small breakeven result in 2026, with financial indicators demonstrating the University's financial sustainability. Council commended Management on the 2026 Budget paper and on achieving the financial outcomes required by Council in 2025.

The Payroll remediation process was underway and to date, \$583k had been paid to 536 staff.

**Risk and Compliance**: Council noted the VC's Strategic Risks; the financial outcomes risk was recommended to be downgraded to green from amber. Compliance with the new Gender Based Violence legislation would be reported at the December meeting.

**People and Culture**: The CPO provided an update on planning for the new Enterprise Bargaining Agreement with structured meetings set until May to discuss matters with the NTEU in good faith. Staff will receive transparent communications. The Workplace Culture report showed strong signs of cultural recovery since the restructure and the 2025 Biennial Staff Engagement Survey showed a strong upward trend across engagement, wellbeing, and progress key indicators.

The Chancellor's Report included the Deputy Chancellor's update on the University Chancellors Council meeting which discussed the Australian Government's new University Governance Principles, and sessions with representatives from Universities Australia, the NTEU, ATEC and the National Union of Students (NUS).

Academic matters included: Council approved the appointment of Professor Tanya Lawlis as the new Chair of the Academic Board to commence a three-year term on 1 January 2026. Emeritus Professor and Professor of Practice appointments were approved. The Block Model discussion paper which is open for consultation was discussed, noting the Academic Board would consider further, and Management would then outline its findings to Council. The Academic Board Chair, Professor Martinez-Marroquin discussed the Board's report which included the Board's advisory role. Professor Rachel Gibson, Executive Dean Faculty of Health, presented an update to Council on Health's strategic initiatives, partnerships, and future student load projections.

The resolutions passed during the open session of the meeting follow.
