

CLEA ROSE TRAVEL AWARD

Conditions of Award

Purpose of the Scholarship

The Clea Rose Travel Award is funded by Ross Dunn OAM, Frances Rose OAM, and Zoe Rose, in memory of their beloved daughter and sister, Clea Rose. This Scholarship aims to encourage students to undertake a Global Learning experience as part of their degree.

Scholarship Details

The Scholarship shall be known as the Clea Rose Travel Award.

This Scholarship is funded by Ross Dunn OAM, Frances Rose OAM, and Zoe Rose.

Eligibility

The Scholarship is open to students in the second year or higher of an undergraduate degree at the University of Canberra. Students must be enrolled to commence an approved Global Learning program in the year in which the scholarship is offered. For the purpose of this scholarship, an approved Global Learning program is one that is undertaken at an institution in which the University of Canberra has a formal partnership.

Application

Applications for the Clea Rose Travel Award close at midnight on the Friday of Week 1 Semester 1 each year.

Students are expected to apply only once through the Application portal available through the Scholarships website. Applicants must answer each question in the application form truly and to the best of their knowledge at the time of applying. Any major change in the application must be conveyed to the Scholarships Office at Scholarships@canberra.edu.au before the closing date. After this date, applications will be considered based on the original application. In case of multiple applications, the latest application will be considered.

Selection

The Selection Committee is comprised of the Scholarships Office, Global Learning and Donor.

The committee will consider the following parameters in the application form:

- 25% Demonstrated financial need;
- 25% Demonstrated barriers and/or challenges faced; and
- 50% Demonstrated leadership roles, work experience, community engagement or volunteer work.

The Scholarships Committee will also consider the following parameters

- Additional written statement outlining Global Learning program plans and how the experience will impact the student; and
- Referee letters.

The Scholarships Office will prepare a shortlist of applications who meet the criteria and provide this to the Scholarships Committee. The Committee reviews applications and ranks these according to the parameters of the scholarship. The Scholarships Office will collate all the information and submit the Committee's recommendations to the Pro Vice Chancellor, Future Students for approval. A final check of eligibility is completed after the census date prior to awarding the Scholarships.

Number of Scholarships

One scholarship will be awarded each year. The Committee reserves the right not to make an award or to make an award at any time to an eligible person.

Value and Tenure of the Scholarship

The value of each scholarship is determined by Ross Dunn OAM, Frances Rose OAM, and Zoe Rose and is currently valued at \$2,500 paid as a one-off payment. The Scholarship money is paid after the census date via Electronic Funds transfer.

Enrolment Conditions

The recipient must be enrolled in an approved Global Learning program after Census Date for the Scholarship to be awarded. In the event of change of program, degree, intermission or discontinuation, the student must notify the Scholarships Office at Scholarships@canberra.edu.au. If a recipient is found ineligible with regards to enrolment or unsatisfactory academic results in the previous semester, the Scholarship may be rescinded.

Recipient Conditions

The recipients are advised that information relevant to the scholarship will be shared between the University of Canberra and the Donor in order to administer the scholarship. Recipients must adhere to the University of Canberra's policies and procedures. Recipients must agree to their academic progress being made known to the scholarship donor.

The recipients are encouraged to liaise and meet with the donor of their Scholarship and provide a brief summary of how the Scholarship assisted them with their studies as directed by the Scholarships Office when required. The Scholarship recipient is also encouraged to participate in publicity for the scholarships from time to time. Recipients may be contacted for an interview and photograph. The University may also publicise the Scholarships by publishing the names of the scholars. Arrangements for such publicity will be made through the either the Scholarships Office, Advancement Office or Marketing Office.

Subject to the information available at the time, the Pro Vice-Chancellor/Associate Vice President (Students, Partnerships and International) may request that the payment for the semester in which the breach of conditions or withdrawal occurs be refunded in part or in full.

Providing False or Misleading Information

The awarding of a scholarship/grant is based on the information provided to the University. An award may be withdrawn at any stage if incorrect, false or misleading information is provided, or relevant information is withheld. This includes circumstances where the false information is unrelated to the assessment in awarding the scholarship/grant.

Deferment

The Scholarship cannot be deferred.

Concurrent holding of Scholarships

A recipient of the Scholarship is permitted to hold concurrent scholarships as outlined in the Scholarships, Prizes, Medals and Awards Policy.

Taxation and Centrelink

Recipients are responsible for seeking taxation and Centrelink advice regarding their own individual circumstances. Scholarships/grants may be regarded as taxable income if a recipient is enrolled on a part-time basis.
