

Clea Rose Travel Award

Conditions of Award

Purpose of the Scholarship

This Scholarship aims to encourage undergraduate students to complete part of their degree overseas.

Scholarship Details

The Scholarship is known as the Clea Rose Travel Award (CRTA) and it is funded by the Donors: Ross Dunn OAM; Frances Rose OAM; and Zoe Rose, supported by occasional generous donations.

About Clea Rose

29 January 1984 -20 August 2005

Clea Rose was a 21-year-old University of Canberra student in the third year of her Tourism Management degree in 2005.

Clea spent the first semester of 2005 on a study abroad program at Colorado State University, USA, which was accredited as part of her UC degree studies.

During her time at Colorado State Clea was an ambassador for this University, for Canberra and for Australia. She made many friends and participated fully in new opportunities that opened for her in Colorado, the USA and around the world as a result of studying abroad.

Clea died soon after returning to Canberra. She was hit by a car driven at high speed through a pedestrian precinct in Civic, late at night, when many young people were gathered. The car had been stolen, and the driver was fleeing a police chase.

Clea's death touched the hearts of the ACT community, particularly our students and staff.

The University awarded Clea her Bachelor of Tourism Management degree posthumously.

The Clea Rose Travel Award is an enduring memorial to Clea's energetic, adventurous and loving spirit, and encouraging other students to live life to the full.



Threshold Eligibility Criteria

To be eligible for the Scholarship, applicants must be approved to commence a *Student Exchange* program in the year in which the Scholarship is offered. This means that applicants must:

- a) be in at least the second year of an undergraduate degree at the University of Canberra; and
- b) have a minimum of a pass average (GPA 4.0 or higher) at the time of scholarship selection.

The *Student Exchange* program refers to study undertaken at one of UC's international partner universities; this does <u>not</u> include independent study programs arranged at an international university of the applicant's choice, or faculty-led study tours.

Application

Applications are submitted via our <u>Scholarship webpage</u>, which provides details including opening and closing dates. Applicants <u>must</u> confirm that all threshold eligibility criteria are met before applying.

To be considered for this Scholarship, applicants must ensure the following sections of the application are completed correctly, in addition to their personal details:

Applicants may apply only once through the Scholarship website. However, multiple applications for different scholarships are permitted if additional space is needed for scholarship specific personal statements.

All questions in the application form must be answered truthfully and to the best of your knowledge at the time of submission. You must inform the Scholarships Office at Scholarships@canberra.edu.au of any significant change to the application before the closing date. After this date, applications will be assessed based on the original version. Where multiple applications are received for the same scholarship, the most recent submission will be considered.

Selection

The Scholarship Committee will assess applications under the following criteria:

- 50% Statement outlining what the scholarship would mean to the applicant and their plans for getting involved in their host university and country
- 50% Demonstrated leadership roles, work experience, community engagement, university involvement or volunteer work

The Scholarships Office will shortlist eligible applications for consideration by the Committee, which will review and rank them in accordance with the selection criteria of the Scholarship. The Committee's recommendations will be submitted to Director, Student Connect, for approval. After the census date, a final eligibility check will be undertaken before confirming the award and arranging payment of funds.

Number of Scholarships

At least one Scholarship will be awarded each year. The University reserves the right not to offer the Scholarship or to award it at any time to an eligible person.

Value and Tenure of the Scholarship

Each Scholarship is currently valued at \$3,000 and is paid as a one-off payment via electronic funds transfer. Payment will be processed in the next available payment run following confirmation of the award, which occurs after the census date.

Enrolment Conditions

In order to receive the CRTA you must be enrolled in an approved Study Exchange program after the census date. In the event of change of program, degree, intermission or discontinuation, you must notify the Scholarships Office at Scholarships@canberra.edu.au. If you are found to be ineligible with regard to enrolment or unsatisfactory academic results in the previous semester, the Scholarship may be rescinded and/or a refund of all or part of the payment may be requested.

Recipient Conditions

Information relevant to the Scholarship will be shared between the University of Canberra and the Donors for the purpose of administering the Scholarship. The recipient must adhere to the University's policies and procedures and agree to the disclosure of their academic progress to the Donors.

Recipients are encouraged to meet with the Donors and to provide a brief written summary of their travel experience and how the CRTA assisted them. Participation in scholarship related publicity may also be requested



from time to time, including interviews and photographs. The University may also publicise the Scholarship by publishing the names of recipients. Arrangements for such publicity will be coordinated through the Scholarships, Advancement or Marketing Office.

Providing False or Misleading Information

The awarding of the CRTA is based on the information provided to the University. An award may be withdrawn at any stage if incorrect, false or misleading information is provided or relevant information is withheld.

Deferment

The Scholarship cannot be deferred.

Taxation and Centrelink

Recipients are responsible for seeking taxation and Centrelink advice regarding their own individual circumstances. The CRTA may be regarded as taxable income if a recipient is enrolled on a part-time basis.
