Our publications reflect what we value in our Centre – global, interdisciplinary, and collaborative work inspired by normative theory and grounded on rigorous empirical research.




# Global Citizens' Assembly on Genome Editing



The Global Citizens' Assembly on Genome Editing aims to put the public at the centre of global conversations on genome editing. In 2023, this global event will bring together up to 100 participants from around the world to deliberate on the urgent ethical and legal questions surrounding genome editing technologies.







This year, our research team conducted the first national case study, with twenty-three ordinary Australians convening at the Museum of Australian Democracy at the Old Parliament House in Canberra for the Australian Citizens' Jury on Genome Editing. Our network of international partners continues to expand, with national case studies also underway in Brazil, China, USA, UK and France.

Selen Ercan, Hans Asenbaum, Nick Vlahos, Francesco Veri and Lucy Parry are among 63 researchers across 12 countries benefitting from Participedia's Phase 2 funding. The Centre has been actively involved in the project since 2016 documenting democratic innovations in Australia and beyond. Led by Professor Bonny Ibhawoh at McMaster University, Phase 2 of Participedia focuses efforts on documenting and analysing cases and methods that respond to key challenges in democracies including representation and human and political rights.

### Canberra Multicultural Service

As part of this partnership, Selen Ercan will supervise Sahana Sehgal's PhD project investigating intercultural engagement amongst culturally and linguistically diverse communities in Australia. # Global Assembly on the Climate and Ecological Emergency

Our Centre is proud to lead the research and evaluation team of the world's first global assembly on the climate and ecological emergency. Included in the research team are Mohammad Abdul-Hwas, Nardine Alnemr, Hans Asenbaum, John Dryzek and Nick Vlahos. The team is led by Nicole Curato who also serves as chair of the Governance and Participation Committee of the Global Assembly.

This research is a collaboration with the Australian National University via former PhD students Pierrick Chalaye and Emerson Sanchez, the Institute of Advanced Sustainability Studies (Germany) and the Democratic Innovations and Legitimacy Group at KU Leuven (Belgium).



### Global Citizens' Assembly Consortium

Our network of partners for the deliberative global citizens' assembly on genome editing continues to grow. At the global level, partners include Missions Publiques (France and Germany), Involve (UK), Genepool Productions, and the University of Tasmania Centre for Law and Genetics. Partners involved in developing national-level deliberative processes include researchers at Wellcome Genome Campus (UK), Keele University (UK), Deakin University, Federal University of Minas Gerais (Brazil), Shenzhen University (China), ETH Zurich (Switzerland), Arizona State University (USA), and ARRIGE (France).



### Democracy R&D

Our Centre is proud to be part of Democracy R&D – a global consortium of advocates, scholars, and practitioners of deliberative democracy. Our Centre is represented by Nick Vlahos, Nardine Alnemr and Nicole Curato in their activities. Democracy R&D convenes monthly regional learning calls on practitioner engagements regarding deliberative minipublics. The coordination working group (Nick is a member) hosted an international conference with practitioners and academics in 2021. In addition, \$50,000 in financial support has been garnered from the Salvia Fondation in Switzerland to support Democracy R&D outreach strategies.

# Earth System Governance Early Career Dialogue

Our Centre continues our involvement with the Earth System Governance Project. This year, our PhD student **Wendy Conway-Lamb** joined 45 early career researchers from around the world to exchange ideas on different aspects of governance and global environmental change. A highlight was the Pecha Kucha session where each participant presented their research project using only 10 slides, 10 seconds per slide: like speed-dating for environmental politics nerds! 


### **Library for All**

Nardine Alnemr, Jane Alver and Wendy Conway-Lamb wrote children's books for Library for All – an Australia-based education technology developer with a global reach.


