For students pursuing a Master's degree or PhD, the internship is intended to foster industry-engaged research, providing valuable insights into applying academic knowledge in practical contexts. For those aiming for careers in the public, private, or third sectors, the internship offers direct, relevant experience to enhance future applications while also offering a deeper understanding of the nature of work in these fields.

The focus of work-integrated learning in this program is to ensure that the internship opportunity, timing, and outcomes are tailored to your individual goals, setting you up for success both during your studies and beyond.

• Higher Degree Researcher Pathway 1: The Professor

In the British university tradition, an Honours degree serves as the primary pathway to a PhD and, ultimately, a career in academia. This pathway typically involves teaching, research, publishing, and contributing to positive societal change.

• Higher Degree Researcher Pathway 2: The R&D Professional

An Honours degree is also a direct entry point into a Master's or PhD by research, with career options that extend beyond academia (though that remains an option for many). Honours graduates often pursue roles in think tanks, research officer positions, and similar roles, including positions with parliamentary bodies.

Admission requirements

To be admitted to the course, applicants require:

a) Completion of an undergraduate degree in an area relevant to their proposed program of study ie business, psychology, politics, economics, communication and an overall GPA of 5.5 or equivalent. The bachelor degree should be completed within the last 10 years.

b) Academic judgement that the student can be expected to achieve an Honours level in the course.

The application process will include a two page proposal outlining the proposed thesis topic, any industry partners, the name and signature of the principal supervisor, background literature, proposed research questions and proposed method.

Additional admission requirements

Students must discuss their proposed research area with a potential supervisor before applying.
